A complete set of Bidding Documents in English may be purchased by interested bidders or their representatives at MEC Cash Office, 2nd Floor, Development House, City Centre upon payment of a non-refundable fee of MK10,000.00 (Ten Thousand Malawi Kwacha) per tender, payable in cash. Bidders should then collect their bidding document from the

Bids clearly marked on the outer envelope with tender name and reference number must be delivered to the address at 7(b) below and deposited in the tender box located at the Reception of MEC Head Offices in Lilongwe in Procurement Department at or before 14:00 hours local time on 30th July 2023. Electronic bidding will not be permitted, and late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address shown at 7(c) below at 14:00 hours local time on 30th July 2023.
